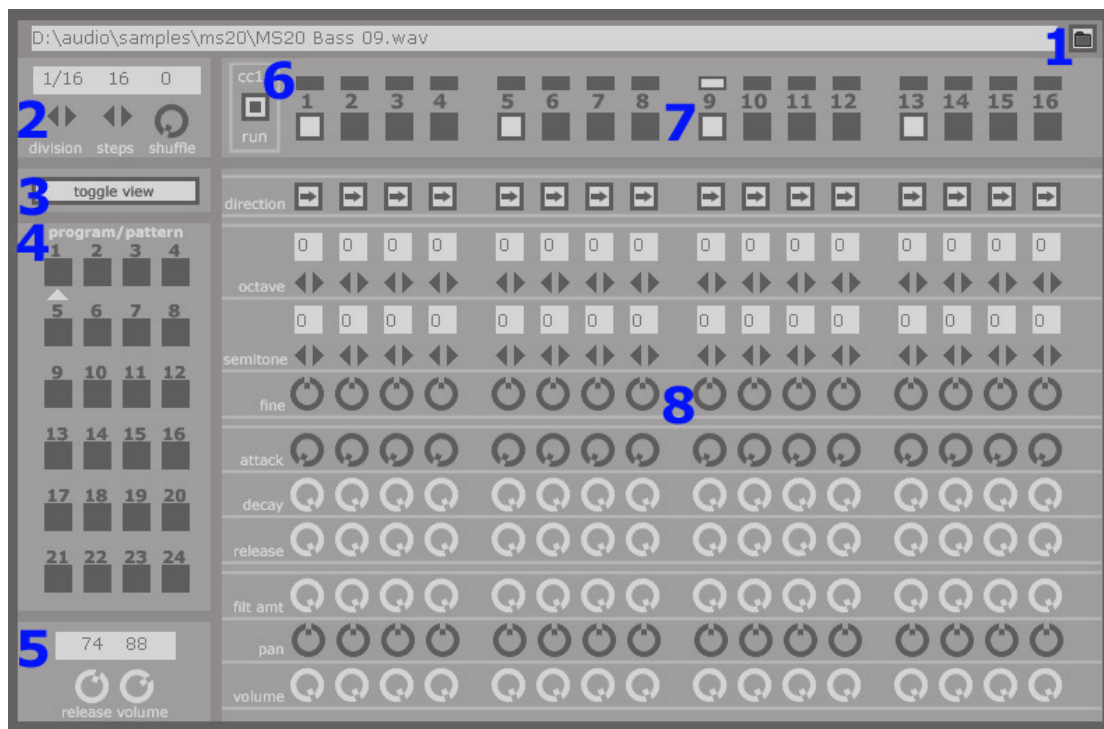

s16 Instructions

To install – just drop the .dll file into your VST folder.



1/ Choose the .wav here.

2/ Choose the division, no. of steps and shuffle amount here.

3/ Toggles between top and LFO/fx page.

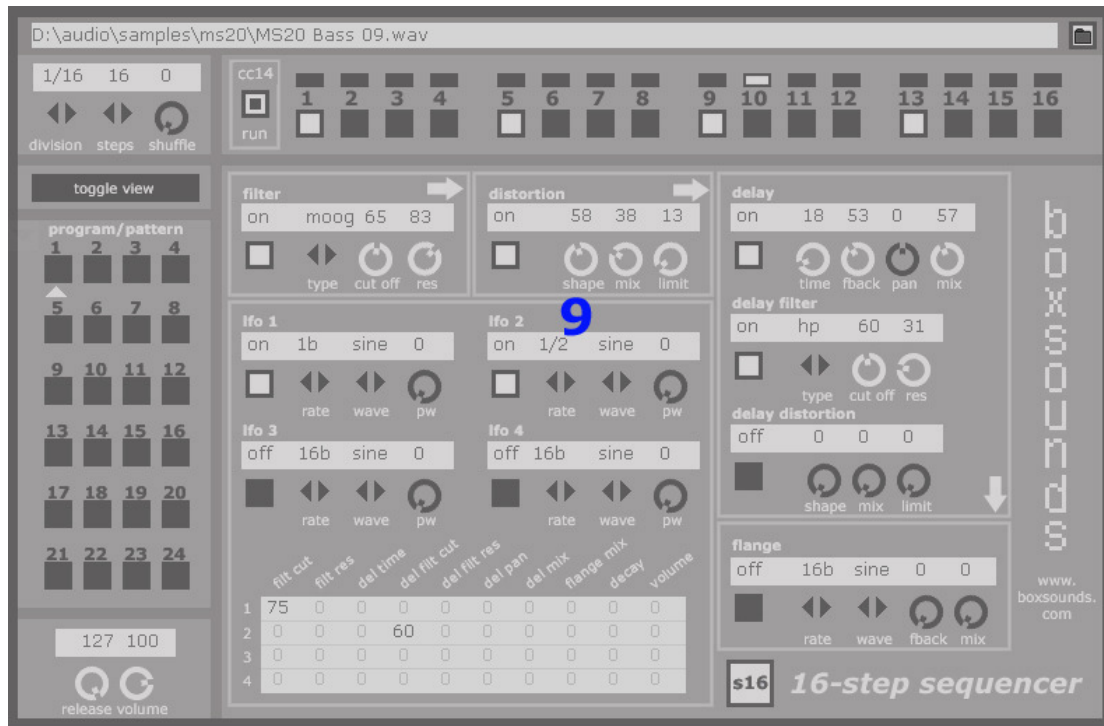
4/ Each pattern is stored as a patch. To copy and paste patterns/patches, use your host's copy/load patch facility. The pattern/program no. can be selected from the GUI, from the host, or via MIDI (note-on C2-B4) from your keyboard or the host's sequencer. No pattern is selected by default when started, so it's probably best to select program 1 straight away.

5/ Global release and volume here – affects all steps.

6/ The sequencer run/stop button.

7/ Step choice.

8/ Lots of stuff to mess around with. Be aware that for filter amount to have an effect the filter must be activated on the LFO/fx page.



9/ More stuff to mess with. To enter an amount on the modulation matrix click and move your mouse up or down; to clear an amount just double-click on it.
